Indian Medical Association Goa State and Goa State Legal Service Authority (GSLSA) organised a symposium/discussion on 16th February 2024 at 5.00 PM in the conference hall of High court of Bombay at Goa on IMA GOA STATE 2024 initiative on Medical futility and End of life care with implementation of Advanced Medical Directives (AMD) better known as "Living Will".



The program was chaired by Shri Justice M.S Sonak, Shri Justice Bharat Deshpande and Dr. Sandesh Chodankar, President IMA Goa State branch. Shri Justice M.S Sonak elaborated on various intricate details of the prevalent directives for Advanced Medical Directives issued by the supreme court of India and congratulated IMA Goa state branch for embracing such activities in the interest of society.













# Dr. Sailesh Kamat, Chairman, Legal Cell IMA Goa State Branch Trade (and Occupation) License – Issues Explained

Disclaimer: This is an attempt to explain legal status as it stands today and not my personal opinion.

There are various misconceptions doing rounds about so called "Trade License" which cause undue anxiety and confusion amongst practicing doctors. Most of the rumour mongering would cease if one realizes that what we know by name "Trade License" is in fact legally "Trade and Occupation License". The situation is worsened by multiple judgements of various courts which do rounds on Whatsapp and other social media further adding to the confusion. Let me take issues one by one

## Why Trade License for medical practitioners when Medical Profession is not trade?

Presuming for a moment that medical Profession is not trade, still so called Trade License is applicable to medical profession as law stands today . The License which we are asked to obtain is either under Goa Municipalities Act 1968 or Goa Panchayat Raj Act. Let us visit the provisions in the said acts.

Coming to Goa Municipalities act 1968, relevant section is quoted herewith.

"Section 265. Certain other trades and occupations not to be carried on without licence.—(1) No person shall use any premises in the municipal area for any trade or occupation except under and in accordance with the conditions of a licence granted under the provisions of the bye-laws made in this behalf." Thus it is clear that you need a license to carry out any occupation within Municipal area. Now it is called "Trade License" because when the law was originally made in 1968, it included only trade. Words "or Occupation" were added by amendment act 9 of 1980. It should have been called "Trade and Occupation License"; which did not happen. But that does not make provision illegal.

Here it is pertinent to note that Section 101 of same act gives power to Municipalities to impose taxes on Professions carried out in it's jurisdiction.

## Medical Profession is a "Profession" and not "Occupation"?

Some practitioners faced with above explanation defended their stand claiming that medical profession is a profession and not occupation. Hence I would like to elaborate that, in legal terms, Occupation is defined as any work that you carry out to make a living while Profession is occupation that requires special skill set and sometimes certification. Thus all professions are occupations but reverse is not true. (Reference: Scrutton L.J, Commissioner's of Inland Revenue v. Maxse)

Applicability of "Trade License" to medical practitioners is further reinforced after promulgamation of Trade and occupation Licensing Byelaws 1989. (Please note that here "Trade License" is referred to as "Trade and occupation License"). The said byelaws were gazetted on 24th August 1989. The Schedule of rates appended to these byelaws under Byelaw 3 and Byelaw 5 Under item No 11 mention Hospitals/Nursing Homes/ Maternity @ Rs 100 per year and Consulting Rooms (Per Unit) @ Rs 50 per year. Having notified rates along with description, published in official gazette, how can one claim that "Trade and Occupation License" is not applicable to medical practitioners.

Having covered Goa Municipalities Act 1968, Let us see provisions in Goa Panchayat Raj Act 1989. Chapter VIII deals with "Taxes and Fees". Section 153 (3) allows Panchayats to levy various fees and taxes. Item No (k) reads as follows.

(k) tax on profession, trades, calling and employment;

Word "Profession" is mentioned here. So we can't even hide under cover of "Occupation"





## Trade License is not required for registration under Clinical establishment Act?

Absolutely correct. Only mention of "Trade License" is found in Goa Clinical establishment Act Rules TABLE I (under rule 4) is in form of item No IV

(IV) Minimum standards as laid down under trade license issued by the Municipal Corporation/Municipal Council/Village Panchayat concerned shall be maintained.

There is no mention that "Trade License" is mandatory. What is required is adherence to minimal standards as laid down under "Trade License"

Point to note here is that just because it is not required under Clinical Establishment Act does not mean that "Trade License" will not be required under other acts in force.

# IDA – Indian Dental Association Has Challenged "Trade License" at High Court and various other forums. Why IMA does not follow suit?

We live in democratic country and anyone aggrieved with any Act/Law can approach High court or Supreme court against the same. Point to note here is that the said suit or representations are not filed by IDA but by Goa Private Dental Practitioners Association, which is a group of private dentists. So comparing it with IMA State Branch would not be appropriate.in democratic country and anyone aggrieved with any Act/Law can approach High court or Supreme court against the same. Here it is pertinent to note that same group of dentists had approached Director of Municipal Administration challenging validity of "Trade License" but their plea was dismissed.

It is interesting though to go through grounds on which they are challenging the applicability of "Trade License" to Dental Profession

- 1.Trade License is required only for commercial activity
- 2.Dentists undertake 'Profession" and should not come under "Occupation" which means commerce and sale of commodities
- 3.Trade and Occupation Licensing Byelaws, 1989 do not specifically cover Dental establishments. It only mentions "Hospitals/maternity/Nursing Homes/Consulting Rooms (per unit)" so legislature has deliberately excluded Dentists
- 4. There is no provision of "Trade License" fees under Corporation of City of Panaji Act, 2002
- 5. Municipalities/ Panchayat are collecting Garbage tax over and above Sanitation tax and also property tax at Panchayat level

Basically there are 2 issues. Applicability of "Trade License" and type and quantum of taxes laid. Let us restrict ourselves to 1st part. So on analysis their important contention is that they are not included under category "Hospitals/maternity/nursing homes/ consulting rooms". Another ground they are raising is definition of occupation itself. Rest are technical grounds.

Let us wait for the HC judgement. However the High Court has not given a stay on implementation of "Trade License" as prayed for in the petition. That means "Trade License" is legal requirement as of date.

# Goa Cabinet has approved imposition of "Professional tax" so now "Trade License" will not be required?

Professional Tax is a misnomer. Although fine print will be clear only after draft of the bill is in public domain, if one follows what is prevalent in other states, anyone whose income is above certain ceiling is liable to pay "Professional tax" and it is not limited only to professionals. It does not replace "Trade License" and hence it is not true that "Trade License" will not be required once "professional tax" is laid.

SO TO CONCLUDE, UNLESS SOMEONE CHALLENGES IT IN HIGH COURT AND OBTAINS STAY OR GETS LAW INVALIDATED, AS OF DATE "TRADE AND OCCUPATION LICENSE" UNDER GOA MUNICIPALITIES ACT IS REQUIRED FOR MEDICAL PRACTITIONERS, EVEN FOR SINGLE CLINICS IN GOA





Various judgements are cited as evidence contrary to applicability of trade license.

Let us visit various judgements to understand their relevance in issue of "Trade License". I will only go through facts of the cases and leave it to the readers to decide whether they have any relevance in present discussion.

#### 1. Devendra Surti vs State of Gujarat

The question involved in this appeal is as to whether a Doctor's dispensary is, a "Commercial Establishment" within the meaning of the Bombay Shops and Establishments Act, 1948. SC decided that Individual Doctor's clinic cannot be called as "Commercial establishment" under Shops and Establishment Act 1984. Although the judgement has no relevance under Goa Municipalities act since under this act it comes under category "Occupation", still it is worthwhile to have a look at the details of the case to see how different courts themselves can have different perspective. Dr Devendra Suri was having his clinic at Ahmedabad and he had taken registration under "Shop and Establishment Act". However inspector found that necessary registers were not maintained and hence filed a case on him. The City Magistrate (First Court), (Muni), Ahmedabad held that the appellant was not guilty and acquitted him. The State of Gujarat took the matter in appeal to the High Court of Gujarat in Criminal Appeal No. 208 of 1964. The appeal was allowed by the High Court by its judgment dated February 14, 1966. They took a stand that since he had registered under the act, he should abide by all provisions. Dr Devendra Surti went in appeal to SC and SC upheld his appeal citing in it's judgement that Individual clinic of a doctor is not a commercial activity.

#### 2. Narendra K Fuladi vs State of Maharashtra

Since Professions like Medicine and legal practitioners were excluded from ambit of Shops and establishment act, State of Maharashtra amended the act to include Medical and legal practitioners. Mr Narendra K Fuladi, a lawyer and Secretary of Akola bar Association challenged the amendment.

Right of legislature to amend the law itself was challenged. Another ground was that Advocates are regulated by Advocates Act so another act is redundant. HC didn't allow both grounds. HC went ahead even to mention that even if present act contravenes provisions of central Advocates Act, it will be legal. HC at the same time upheld that Professions like legal practitioners and medical practitioners do not come under ambit of Shop and Establishment act because The act is made to regulate commercial establishments from point of view of welfare of the employees. Single clinics of doctor or lawyer has maximum one employee and hence it can be said that law at the time of formulation envisaged to exclude legal and medical practitioners.

## 1. Dr Pradip Arora vs State of Maharashtra

Having faced setback in above two and some more related cases, Maharashtra Govt came up with amendments and changed full format of the act. The new act was called "Maharashtra Shop and Establishment Act 2017". In this act "Commercial establishment" was changed to "establishment" and establishment of any medical practitioner (including hospital, dispensary, clinic, polyclinic, maternity home and such others) was enlisted in inclusions. The amended act was challenged in High Court by Dr Pradip Arora, an paediatric Surgeon and an activist. The High Court of Bombay after going through and dissecting the amended act threadbare delivered their verdict that Maharashtra Shop and Establishment Act 2017 was applicable to Medical Practitioners. By virtue of provisions of the Act, Establishments having more than 10 employees are required to register and follow all sections of the Act whereas establishments having less than 10 employees are not required to register or follow all sections of the act but are required to send information of establishment to appropriate authority (Described as Facilitator) If one reads the judgement it is made clear that in present form, Medical Practitioners are included under Ambit of Maharashtra Shop & Establishment Act 2017. This is valid position of law as of today till reversed by SC if at all. One thing is pretty clear from above 3 judgements is that Government has full right to Amend acts in order to remove clauses considered invalid by courts and Courts have upheld this right of legislature. In this scenario, I have my doubts, how smart is the move to challenge application of "Trade License" to medical practitioners under Goa Municipalities Act.
